### Summary of CLC Meeting Discussions

#	Item	Action
8.1	The Committee was informed of CLC Membership changes. Dennis Perlotto has left AIM, and Kim Ungar will replace Dennis as Chair to the CLC. Andrew Philopoulos was welcomed as the new Manager of HRM Solid Waste Resources and will be representing HRM along with Krista Flanagan. Jordan Vallis will act as alternate for HRM.	
8.2	Copies of the Summary Notes of Meeting #7 were distributed and reviewed by the Committee. The notes were approved as recorded. Vote to approve meeting notes was motioned and seconded by Maureen and Kim.	
8.3	AIM has updated website with current documents monthly reports need to be added for 2019.	K. Ungar to upload documents to AIM website
8.4	The Committee was informed that the AIM notice had been removed but has been posted again at the entrance of the Irving/Circle K. The "Notice Cards" are still available behind the counter should a customer enquire about odour or the plant. Kim continues to follow up on a regular basis. They do have a sign posted and cards available to give out.	K. Ungar will continue to monitor periodically
8.5	The Screening Building Roof Replacement Permit was issued on May 31, 2019. Public notices were posted on AIM website and Halifax website as per previous discussions from the CLC. NSE was also notified of the project. Project commenced on September 3 <sup>rd</sup> and should take about 3 weeks to complete.	
8.6	K. Ungar notified the Committee that a new Approval to Operate was issued from Nova Scotia Environment with similar operating and monitoring procedures. There were no complaints received since February 2019. A new loader (JD 644) was leased for the site to help in operations as the old 621 will be retired.	
8.7	K. Ungar provided an update on the Screening Building Project which began on September 3 <sup>rd</sup> . He stated that the screening building demolition portion was complete. The screening building was completely emptied and cleaned of material before demolition to minimize odor issues. The project is scheduled to be completed by the end of September.
